IMT Medical Transport Limited Privacy Statement.

This privacy statement discloses the privacy practices for this website and our Company practices. It explains how IMT Medical Transport Limited uses any information you give to us, and the way we protect your privacy. Protecting the privacy and personal data of the visitors to our site and that of our patients and clients is of the utmost importance to us.

UK GDPR

IMT Medical Transport Limited has a legal duty to protect any personal information we collect from you and about you as a visitor to our site or as a patient or as a client when this is provided to us by an NHS Trust or by yourself.

YOUR RIGHTS

You have rights as an individual, which you can exercise in relation to the information we hold about you. These are:

A right of access to a copy of the information comprised in their personal data.

A right to object to processing that is likely to cause or is causing damage or distress.

A right to prevent processing for direct marketing.

A right to object to decisions being taken by automated means.

A right in certain circumstances to have inaccurate personal data rectified, blocked, erased or destroyed.

A right to claim compensation for damages caused by a breach.

Information collection and use.

We will only use your information for the purpose as described and we do not pass on your details to any other government department or third party unless you have given us permission, or we have a legal responsibility to do so. You have a right to access your personal data and rectify any inaccuracies.

We will record your email address and other information if volunteered to us by you. This shall be treated as proprietary and confidential. It may be used for internal review and to notify you about updates to this website information.

Any information which you send to us through this website will be treated as follows:

We will keep it no longer than we reasonably believe is necessary.

We will use it only for the purpose for which you sent it.

Cookie information.
